### **BOOKING PROCEDURES:**

Ticket purchases are not considered confirmed until full payment is received and you have received a confirmation from GET Sports. Features for all plans are subject to change and may be based on features available at time of arrival, not those in effect at time of booking. All guests' full, legal names and children's ages are required at time of booking.

### **GREAT AMERICA THEME PARK TICKETS TERMS & CONDITIONS**

OFFICIAL NOTICE: The specially priced theme park ticket policies and procedures have changed from previous events and these terms serve as notice to all GET Sports account holders and their guests.

- **-Halloween Haunt Upgrade is not a stand-alone ticket and must be used in conjunction with a Single Day or 2-Day Ticket.**
- -All specially priced tickets sold by GET Sports for this event must be used over the dates of October 7th and/or October 8th, 2017.
- **SINGLE DAY TICKETS VALID ONLY ON SAT, OCT 7<sup>TH</sup>, 2017**
- **MULTI DAY TICKETS VALID ON BOTH SAT, OCT 7<sup>TH</sup> & SUN, OCT 8<sup>TH</sup>, 2017**
- -Tickets are sold by GET Sports in advance of guest arrival only.
- -All tickets purchased through GET Sports will be emailed to the guest
- -All tickets on account are considered FINAL and will be NON REFUNDABLE with no changes, exchanges or returns.
- -The amount paid for tickets purchased through GET Sports cannot be applied toward upgraded tickets or annual passes with Great America.
- -Tickets lost, damaged, stolen or not used are not replaceable or refundable.
- -Tickets ordered in advance are also available to family, friends and spectators.
- -Prices are available through GET Sports and include sales tax. All tickets and ticket options are non-transferable, non-deferrable, non-changeable and non-refundable.
- -Valid for admission to Park during the date(s) printed on the front of ticket.
- -Tickets are non-refundable once they have left the possession of GET Sports.
- -Purchaser assumes full responsibility for all tickets purchased, including tickets that may be misplaced, lost and/or stolen then redeemed.
- -Prices, hours, dates, and attraction availability are subject to change without notice and Park operating days are "rain or shine" (no refunds or rain checks due to inclement weather).
- -Park reserves the right to be closed to the public and Season Pass holders for private Events, capacity limitations, and other reasons. Certain attractions and/or Park facilities may be closed due to inclement weather, extreme temperatures, maintenance, and/or other reasons.
- -Food or beverages may not be brought into or taken out of any group function at Park.
