TERMS AND CONDITIONS FOR WALT DISNEY WORLD® MARATHONS

Please be advised that in the event any changes are made to the reservation including, but not limited to, changes in travel dates, updated Terms and Conditions may apply to the modified reservation.

Package Rates:

All prices are in U.S. dollars and are subject to change until package is paid in full. Prices are for the total package and cannot be broken down into individual package component prices. After package is paid in full, package price is subject to change due to imposition of taxes or other charges of governmental authorities. Prices are also subject to change due to modifications to package or package components. **Everyone on the same reservation must be on the same package.** Additional adult charges shall apply for more than one adult(s) and/or Child(ren) per room. Package shall include Hotel, admission and must include at least one occupant registered in the *Run*Disney event. Packages quoted without deposit or issued confirmation number are considered quote only and subject to increase upon final booking. Final booking is subject to availability at time of deposit and re-confirmation from *Run*Disney. Quotes are not a guarantee of package/pricing but an estimated cost at time of request. Registrations/rooming are on a first come first serve basis, subject to change and sold out status of real time.

Reservation Requirements:

- All guests' full, legal names (including children) are required by the final rooming list due date. Children's ages are also required. Date of birth and gender are required for all guests, including infants, if the reservation includes air transportation.
- Name changes are not permitted; reservations and package components are nontransferable.
- Reservations are not accepted until confirmed by a confirmation number

Deposit and Payment Procedures:

For reservations, a deposit of \$200 per reservation will be due and must be received by GET TRAVEL at the time of booking the reservation or the reservation/rate is not guaranteed. Deposit on room and Registrations are non-refundable. Payment may be made with a valid credit card or by check or wire transfer. For reservations that include runDisney race registrations, the cost of such race registrations is due at the time of booking and is non-refundable. Guest will be responsible for any cancellation fees assessed at time of cancellation. No refunds will be made for early departure from hotel and for unused or partially used admission tickets, options or features, including meals. All package balances must be paid in full no less than 30 days prior to first check in date or as established below by Event:

- 2019 Star Wars Virtual Half Marathon-December 3rd 2019
- 2019 Disney Princess Marathon-Final Payment deadline January 18th 2019

Change Fees and Changes to Reservations Made Prior to Guest Arrival:

Changes to Reservation – Changes to reservation, including but not limited to change in travel dates, length of stay or hotel accommodations, are subject to availability at the time the change is requested and guest is responsible for paying any increase in price resulting from the change. In addition, changes made 30 days or less prior to guest arrival are also subject to a change fee of \$50 per package plus any change fees assessed by *Run*Disney and/or Disney hotel management.

Disney Package Arrival Documents:

Additional fees will be charged for the replacement of any lost or misplaced travel documents. For packages other than *Magic Your Way* packages, Guests can pick up Disney theme park attraction tickets and certain other fulfillment cards at the guest's resort hotel upon arrival. Guests with *Magic Your Way* packages may have entitlements linked to an account they create online ("Disney account") and ticket and other entitlements will be fulfilled via a MagicBand or radio frequency card. Title to the documents, including any radio frequency devices, passes in Lake Buena Vista, Florida upon delivery of the documents to the shipper or the mailing of the documents. Recipient is responsible for any duty or custom charges or expenses. Persons who are requesting documents to be shipped to friends or family members outside the USA should so note. Vouchers, if applicable, must be presented at time of use.

Attractions, Tickets and Features

Parks, restaurants, attractions, recreation, *FastPass+* selections, entertainment, and other products, services or items are subject to change without notice, cancellation, and may close temporarily due to rehabilitation, refurbishing, capacity, seasonal, inclement weather or special events and may otherwise change or be discontinued without notice and without liability to the owners of the *Walt Disney World®* Resort. Ticket media is not valid for special or premium events or other activities which are separately priced. Admission entitlements are non-transferrable, not for resale, and must be used by the same person on any and all days. Age restrictions apply for access to certain facilities. Guests must be 21 years of age or older with valid proof of age to redeem alcohol entitlements. Features for all packages are subject to change and may be based on features available on date of guest arrival, not those in effect at time the reservation is made. Costs for parking (self and valet) at certain locations, incidentals, gratuities, child care and any other items not specifically listed as part of the package components are not included in the package price.

Disney's Magical Express Transportation:

Disney's Entities shall have no liability for the loss of or damage to cash, financial instruments, precious metals, silverware, jewelry, works of art, medicine, cell phones or other valuables computer/photographic/video/audio equipment. No pets will be transported by Disney's Magical Express transportation except for service animals. Complimentary transportation services provided by Disney's Magical Express service are provided to guests staying in select *Walt Disney World*[®] Resort hotels and include a one-way ground transfer between Orlando

International Airport and guest's *Disney Resort* hotel on the day guest checks in and a one-way ground transfer from guest's *Disney Resort* hotel to Orlando International Airport on the day guest checks out. Stays outside of the Disney Hotel check in and check out dates shall not be permitted on shuttles.

Resort Check-In/Check-Out

Check-in time is generally between 3 and 4 p.m. (some hotels have check-in after 4 p.m.), and check-out time is usually between 11 a.m. and 12 noon.

Room Location and Information

Adjacent rooms, connecting rooms or specific room location and types of rooms or bedding are on a "request basis only" and are subject to availability at the time of check-in. These requests for specific room type or location may result in additional charges to be paid directly to the hotel. Disney owned and operated resort hotels and Disney Vacation Club resorts are smoke free environments. Smoking is allowed in designated outdoor smoking locations only. A room recovery fee will be charged for smoking in guest rooms, on balconies or on patios.
